

Publication of list of individuals and entities under the United Nations Sanctions (Yemen) Regulation 2019 on CEDB's website

On 31 July 2024 (New York Time), the Committee of the Security Council of the United Nations (“UNSC”) pursuant to UNSC Resolution 2140 (2014) **concerning Yemen removed two individuals** on its sanctions list. Please refer to the [press release](#) for details.

2. Pursuant to sections 30 and 31 of the United Nations Sanctions (Yemen) Regulation 2019 (Cap.537CI) (“the Regulation”), two updated lists of individuals and entities were published on [CEDB’s website](#) at 11:00 am on 1 August 2024. Sections 2 and 3 of the Regulation prohibit the supply, sale, transfer and carriage of prohibited goods (i.e. arms or related material) to individuals and entities on the list published under section 30 as well as those acting on behalf of or acting at the direction of such individuals and entities. Section 4 of the Regulation prohibits the provision of any assistance related to military activities or the provision, maintenance or use of any arms or related material to individuals and entities on the list published under section 30 as well as those acting on behalf of or acting at the direction of such individuals and entities. Section 5 of the Regulation prohibits the making available of any economic assets to or for the benefit of persons and entities on the list published under section 31; as well as dealing with any economic assets belonging to, or owned or controlled by such persons or entities.
